## **BOARD OF DIRECTORS MEETING**

1. **Board President Nathan Ausley called the Board Meeting to order at 5:40 p.m.**
2. **Public Comment**  
Kyla Lawhon and Roy Crumnow addressed the board with concerns on the registering of exempt wells.
3. **Approve Minutes of the May 11, 2004 Board Meeting**  
Director Dwayne Jekel made to motion to approve the minutes and Director Jay Wilder 2<sup>nd</sup> the motion. The motion passed unanimously.
4. **Receive Certificate of Completion for the District's Management Plan From the Texas Water Development Board**  
General Manager Gary Westbrook presented the certificate of completion on The District's Manage Plan as approved for completeness by the Texas Water Development Board.
5. **Consider and Act on Final Adoption of the Rules**  
The Rules of the Post Oak Savannah Groundwater District were adopted and re-adopted by the Board of Directors. The motion to adopt and re-adopt was made by President Nathan Ausley and 2<sup>nd</sup> by Director Dwayne Jekel. The motion carried unanimously.
6. **Received Report From The District Manager On Recent District Activities**
  - A. Permit Application Hearings will be set for all non-exempt permit applications that have been submitted to the District. Possible hearing dates will be set preceding the next scheduled board meeting.
  - B. A report on new well recordings to date was given. We have had five (5) applications to drill new wells and forty two (42) applications submitted for recording existing exempt wells.
  - D. The District Manager reported that applications to record wells have been placed in both counties at local feed stores in eleven (11) different locations. Applications can be picked up, filled out, and mailed into the district.
7. **District Personnel Policies, Content, Process, Procedures And Actions**  
The District's personnel policy was presented and the policy was accepted. President Nathan Ausley made the motion to accept the current personnel policies and Director Jay Tumlinson 2<sup>nd</sup> the motion. The motion carried unanimously.
8. **Bills Received and Current Financial Status**

General Manager Gary Westbrook presented bills received and current financial status. Motion by Director Robert Ware to approve payment of all bills and Director Kerry Starnes 2<sup>nd</sup> the motion to approve all bills. The motion carried unanimously.
