"My name is _____. I am of sound mind and over eighteen (18) years of age. I am the owner of land located at _____ in _____ County, Texas ("Land"). My address is _____, _____, _____, and I and am personally acquainted with the facts stated herein and such facts are true and correct. The Land is the same property, or is included within the boundaries of the same property, that is described in Section IV of the Application for FRAC or Stimulation Oil and Gas Permit to which this Affidavit is attached.
