### MINUTES

**1. Call to Order**

Chairman Ausley called the committee meeting to order at 3:05 pm

**2. 2009 Budget**

The committee reviewed and discussed necessary upcoming amendments to the 2009 Budget

**3. Property improvements**

The committee considered and discussed possible improvements to the property for the coming year. It was decided that improvements to the yard should wait indefinitely.

**4. 2010 Budget**

Items 4 through 6 were opened together. The committee considered and discussed items in the 2010 Budget, along with Production fees and Transport Fees. It was recommended that these items be discussed with the full Board at the meeting later on this date.

**7. Schedule of Fees**

The committee reviewed the current schedule of fees of the District. No changes were recommended.

**8. 2009 Groundwater Conservation Grants**

The committee discussed the year 2009 Groundwater Conservation Grant Program with respect to the amount in the 2009 Budget to be awarded and the current level of awarded grants for this year. It was decided that the full Board should decide how to handle the amount remaining in the 2009 Budget for this item at the meeting later today.

**9. Schedule of Penalties and Fines**

The committee reviewed this amended Schedule as presented and made several additional amendments. It was agreed to present this amended Schedule to the Board later on this date for final approval to move forward to a Rules hearing later this year.

**10. Rules**

A brief review of rules for item #9 above and minor clean-up of the District Rules was reviewed. These rules are to be considered during the same hearings as the schedule in item #9 above.

**11. Liaison Committee to neighboring Districts**

After discussion of the purpose of this committee, which is to meet with a similar committee from our neighboring Districts to address mutual concerns and management strategies, it was decided to recommend to the Board appointment of either two or three Directors who volunteer to serve.

**12. Authorization for Groundwater Monitoring Wells**

An agreement which was drawn up by District's attorneys to serve the purpose of structuring an agreement between the District and citizens of the District for the use of their wells as monitor wells was reviewed. It was recommended to the Board that this agreement be approved for use and that the General Manager be able to execute the agreement on behalf of the District.
