### **1. Call to Order**

The meeting was called to order at 5:04 p.m.

### **2. Update on improvements to Central Queen City-Sparta/Carrizo Wilcox Groundwater Availability Model**

A presentation entitled, “Status Update of GMA 12 GAM Project” was given by Steve Young with Intera. No action was taken by the committee.

### **3. Receive report from District Staff on results of recent water level monitoring**

A report titled “To Infinity and Beyond” was given by Bobby Bazan with Post Oak Savannah GCD reporting and outlining recent water level monitoring work.

### **4. Receive updates from District Staff on expansion and improvements to District Well Monitoring Network**

Mr. Bazan continued his report discussing future plans to expand and improve the District’s Monitoring Network. He noted that plans are to add 50 monitor wells in the shallow management zones of the Carrizo-Wilcox formations in the District by August 2017, and to equip 25 of those with transducers to automatically record water levels, as well as telemetry for automatic uploads which will then be made available on the District’s website at [www.posgcd.org](http://www.posgcd.org).

GM Gary Westbrook then provided a summary and asked all citizens to support the District in this endeavor.
