Can you confirm how you want us to do the notifications (email or phone call) and who they should go to? For the most part, we've stopped discharges at Agua Vista Station that would go into Mud Creek. However, if we have a day with really low customer demands that makes it difficult to distribute all the water (such as a rain event), we might have to do a short-term release to avoid overflowing tanks. This possibility should go away after we complete the tunnel in July and move into the next phases of integration of this water supply. Just let us know the best way to notify Parks because it might be a plant operator having to make this notification in the middle of the night.

Mark,

Can you confirm which location Parks is concerned about this new discharge? We significantly reduced discharge last Friday from the Agua Vista Station to the drainage easement upstream of Mud Creek because we started flushing the pipeline to our Bitters Pump Station, which is located at Bitters and West Avenue. That discharge meanders through the City storm water system toward Salado Creek but can be seen at some low water crossings. Is that what you're referring to? The flow varies because we are not flushing at a constant rate. We're still serving the Stone Oak area from the Agua Vista Station, and the customer demands vary. Let me know if that helps clarify.

We are planning on starting production at our Agua Vista Station again on Monday April 6<sup>th</sup>. We will be discharging again through Mud Creek.

Discharge will be approximately 30 – 40 million gallons per day for about 3-5 days, then we will reduce to 20 million gallons per day for about a week.

We are hoping to reduce the discharge to no more than 10 million gallons per day after that for about a month at which time we hope to further reduce discharge flow.

All discharge will be potable water quality and meet all regulatory requirements.
