

You have been identified as a person with an interest in land or a water well required to receive notice of a public hearing to consider the applications submitted to Post Oak Savannah Groundwater Conservation District (POSGCD) on July 7, 2020 by Beaver Creek WCID No. 1, 3380 Beaver Creek Drive, Caldwell, TX 77836, requesting exceptions to spacing requirements according to the District's Rules in the operation of two groundwater wells to be used for municipal water supply to the Beaver Creek WCID No. 1 CCN. Upon approval, the applicant would be granted one or more of the following permits: authorization to operate a groundwater well at the rate of 175 gallons per minute. The following landowners are identified to receive notice: owners of land that abuts the land proposed for the well site within one-half mile of the proposed well, and all registered and permitted wells, within one- half mile of the proposed well site.

<u>Well Location Description</u> These wells are to be located within the Beaver Creek Subdivision as follows: Well #1 will be located near the intersection of Teal Lake Drive and Pin Oak Lane at latitude 30 26'24.65"N, longitude 96 34'38.58"W on Lot 600, Section 3, in Beaver Creek Subdivision, Burleson County Texas; Well #2 will be located near the intersection of Mallard Drive and Lake Ridge at latitude 30 26'44.57"N, longitude 96 33'14.17"W on Lot 249-A, Section 2, in Beaver Creek Subdivision, Burleson County Texas.
