DISTRICT ADDRESSES DECLINING WATER LEVELS

DISTRICT ADDRESSES DECLINING WATER LEVELS

In local gatherings across our District, conversations between family, friends, and neighbors are being had about the weather, politics, sports, and local gossip. These days those conversations may include stories about someone's water well going dry or a pump burning up. The chalter certainly stirs up emotions and folks begin to wonder, "Is this going to happen to me?" "Am I next?"

Not that you didn't trust your neighbors or family, but the chalter is true and some wells in Burlesson county have experienced issues with their water well due to declining water levels in the Carrizo and Simsboro aquifers. Since October 2020, Post Oak Savannah GCD has responded to a fair number of calls from well owners reporting issues with their water well fund to a fair number of calls from well owners reporting issues with their water well. That is not meant to minimize the why and how we got to this point.

Board members and staff at POSGCD are well aware of the concerns that citizens have about the Vista Ridge project, and some landowners are even frustrated that permits were issued in the first place. However, under stale hav, a landowner owns the water the third and as real property, which allows them to produce it, sell it, lease it, or simply leave it in place if they so choose. The role of the District, as mandated by law is, to strike a balance between conservation of the aquifers and allowing a landowner's right to use or assign the use of their groundwater under their property. Groundwater districts issue permits for the purpose of regulating that use.

With the permits long issued and the Vista Ridge project preparing togo online, all the science and hydrology principles suggested that we would see these near immediate changes. In anticipation of the impacts, the Board created and adopte

Another bry-product of the GWAP is an annual report known as the GWAP Annual Needs Assessment (GANA). This report takes all the data that the District collects, such as well reports, water level measurements, annual production, etc., and predicts which wells are likely to be impacted. This allows the District to be proactive and work with well owners to fix foreseen sissues before any problems arise. Now, there are some limitations with this report. Certain information about a well is needed to make a valid assessment. First and foremost, we need to have the correct location and depth for a water well. This is creat because it allows us to know which aquifer your well is drilled into. Secondly, we would like to know how deep the pump is set in the well. Without this information to many assumptions would be made and lead to urrely-able results. Due to this lack of information some wells were not able to be identified before issues were experienced. Every month POSCCD publishes a summary report on the number of wells serviced (see table above), which can be found on our website. All but one well serviced to date have been Carrizo wells ranging from 300 feet to 800 feet deep in western Burleson county, with the lone exception being a deep Simsboro well. The District is aware of a number of Carrizo wells in the same area that still need to be addressed. The District staff has started contacting, or are attempting to contact those landowners.


