## Monitoring Well Summary

- -323 MONITOR WELLS, INCREASED FROM 292, COVERING 8 AQUIFERS
- -31 MONITOR WELLS EQUIPPED WITH TRANSDUCERS TO RECORD CONTINUOUS HOURLY MEASUREMENTS
- -28 MONITOR WELLS, INCREASED FROM 10, EQUIPPED WITH ACOUSTIC DEVICES PROVIDING REAL TIME REPORTING
- -10 MONITOR WELLS, INCREASED FROM 8, FROM CONVERTED ABANDONED OIL AND GAS WELLS IN STRATEGIC AREAS
- -5 MONITOR WELLS DRILLED BY THE DISTRICT IN STRATEGICALLY LOCATED PLACES

- -WATER LEVEL MONITORING INFORMATION AVAILABLE TO YOU 24/7 THROUGH
- ACCESS OF THE DISTRICT'S WEBSITE ON YOUR DEVICE

## Groundwater Conservation Grants

- -1 MILLION AWARDED THROUGH 6 GRANTS DURING 2021 TO PUBLIC WATER UTILITIES IN BOTH COUNTIES, BRINGING THE TOTAL SINCE 2006 TO MORE THAN 100 GRANTS TOTALING \$15.3 MILLION AWARDED FOR GROUNDWATER CONSERVATION
- ALL LOCAL WATER UTILITIES IN THE DISTRICT HAVE RECIVED FUNDING
- -\$5,942 AWARDED TO LOCAL VOLUNTEER FIRE DEPARTMENTS FOR WATER CONSERVATION MATERIALS AND NOZZLES

-18 RAINWATER HARVESTING SYSTEMS INSTALLED SINCE 1-1-20 WITH 27 CISTERNS WITH A TOTAL OF 100,260 GALLONS OF STORAGE

-\$15,209 AWARDED SINCE 1-1-20 TO PLUG ABANDONED WATER WELLS

- -DURING 2020 COOPERATIVE CONSERVATION CLASSES THROUGH TEXAS A&M AGRILIFE WITH 5 WORKSHOPS SERVING 138 WITH CLASSES ON RAINWATER HARVESTING, EARTHKIND, AND IRRIGATION WITH COLLECTED RAINWATER
- -DURING 2021 4 MORE WORKSHOPS SERVING A TOTAL OF 231 PERSONS
- -COOPERATIVE WATER QUALITY TESTING FOR MORE THAN 100 PRIVATELY OWNED WATER WELLS

- -REMAINS A BIG PART OF OUR OUTREACH TO CITIZENS AND LANDOWNERS.
- -COMPLETED UPGRADE AND UPDATE TO WEBSITE IN 2021
  - >NOW RUNS 25% FASTER
  - >MORE USER FRIENDLY = MUCH EASIER TO NAVIGATE
- -IN 2020 OUR WEBSITE ENJOYED A TOTAL OF 27,913 PAGE VIEWS DURING 10,578 SESSIONS FROM 9251 VISITORS. THIS YIELDS AN AVERAGE DAILY PAGE VIEW COUNT OF 76.3, WITH AN AVERAGE OF 253 VISITORS PER DAY.

- -2021 DAILEY VIEWS INCREASED TO 106.7 WITH 34.4 VISITORS/DAY -POSGCD TWITTER ACCOUNT RECEIVES AN AVERAGE OF 54 VIEWS
- PER DAY WITH 376 FOLLOWERS
- -FACEBOOK POSTS AVERAGING 22 VIEWS AND 100% RETENTION.

## AQUIFER CONSERVANCY PROGRAM (ACP)

- -NOW OVER 600 PARCELS AND MORE THAN 45,000 ACRES ENROLLED
- -OVER 70% OF ENROLLED ACRES FOR 20 YEARS
- -GOOD DISTRIBUTION OVER THE 2 COUNTIES
- -WHY NOT JOIN YOUR NEIGHBORS AND SIGN-UP TODAY?!



## GROUNDWATER WELL ASSISTANCE PROGRAM (GWAP)

- -EFFECTIVELY IMPLEMENTED
- -MOST AFFECTED WELLS IDENTIFIED AND CORRECTED BEFORE LOSS OF SERVICE

- -AVERAGE RESPONSE TIME LESS THAN 48 HOURS
- -AVERAGE TIME TO RESOLVE ISSUES IS LESS THAN 4 DAYS
- -FUNDED BY FEES COLLECTED BY THE DISTRICT AT APPROX. \$150,000 / YEAR
- -EFFORTS INCLUDE SCIENCE AS WELL AS ASSISTANCE
- -WELLS ON LEASED PROPERTIES REIMBURSED TO DISTRICT BY LESSEES
- -MONTHLY UPDATES WITH TOTALS TO BOARD AND POSTED ON WEBSITE

- -ADDITIONAL VETTING OF AQUIFER BONUDARIES AND PROPERTIES IN CARRIZO-WILCOX OUTCROP
- -IMPROVED RELIABILITY IN THE METHODS AND CRITERIA USED TO EVALUATE DFC COMPLIANCE
- -ASSESSMENT OF UNCERTAINTY IN LOGN-TERM FORECAST OF PUMPING IMPACTS
- -STRETCHING OUR \$ INVESTIGATING OPPORTUNITIES FOR COLLABORATIVE STUDIES
