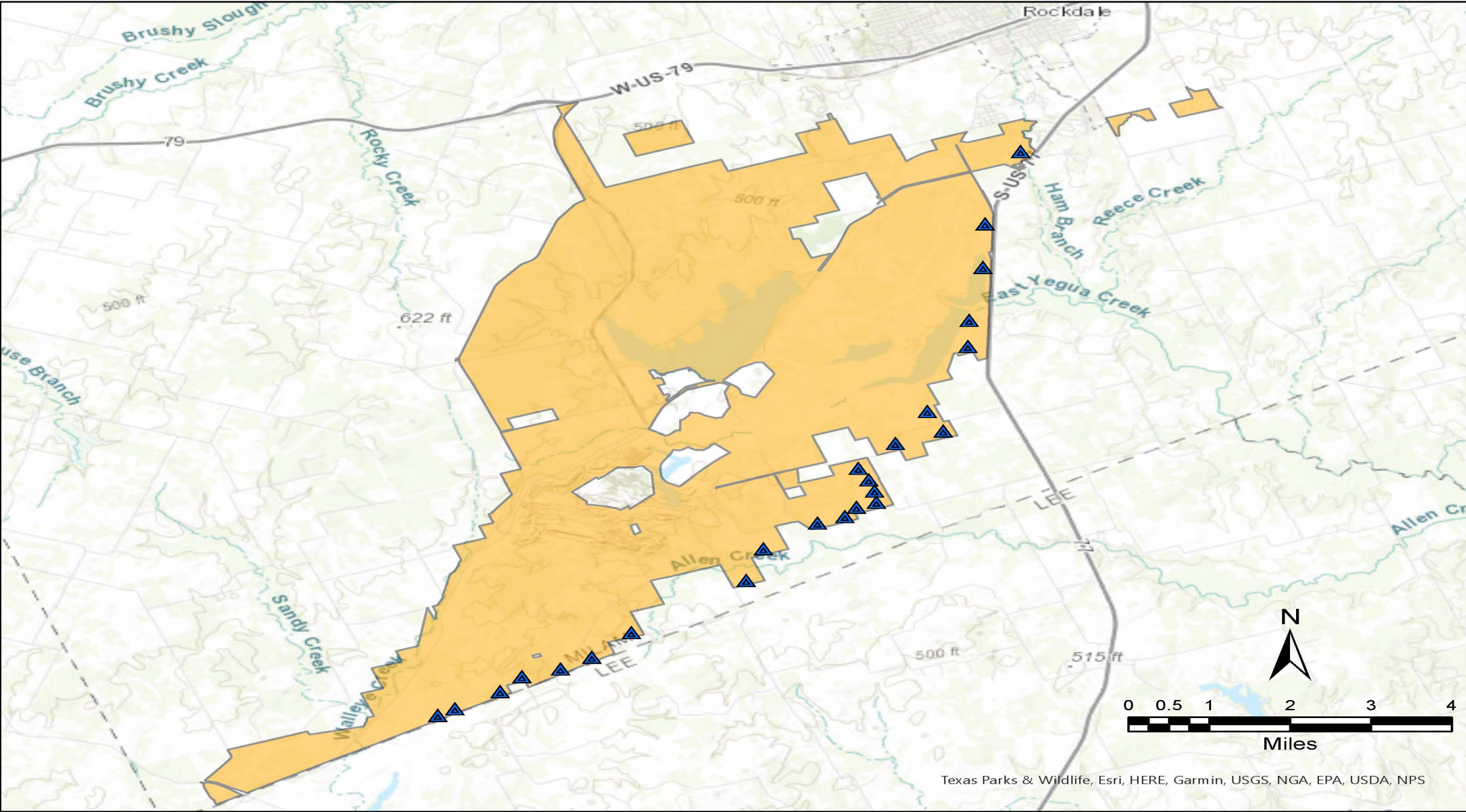


# New Administratively Complete Application: 15,000 Acre-foot Simsboro

- **Applicant Request:**

- Production from the Simsboro formation
- New production permit to be used in conjunction with the HUP 0330 and both permits shall not exceed 15,000 acre-feet total
- If approved, 15,000 acre-feet will be assigned to Historic Use permit and 0 acre-feet to new operating permit
- As new operating permit is used, HUP permit will decrease in equal amount
- Amount assigned to HUP may never be increased above the last amount assigned
- New Operating Permit Uses: Municipal, Industrial, Manufacturing and Commercial anywhere in Milam and Burleson Counties
- Operating Permit to be issued for 40-year term
- Not looking for extension of HUP 0330







# New Administratively Complete Application: 9,000 Acre-foot Simsboro & Hooper

- **Applicant Request:**

- Production from the Simsboro and Hooper formation
- Maximum 9,000 acre-feet from Simsboro and Maximum 4,500 acre-feet from Hooper, total production not to exceed 9,000 acre-feet per year
- Production can alternate between formations
- 60 new wells at 30 defined well sites
- New Operating Permit Uses: Municipal, Industrial, manufacturing and commercial anywhere in Milam and Burleson Counties
- Permit to be issued for 40-year term
