2. Invocation

GM Westbrook gave the invocation.

3. Call to Order and establish quorum

Board President Ward Roddam called the meeting to order at 5:35 pm. The Board convened into executive session at 5:35 pm under section 551.072.

The Board reconvened into regular session at 6:21 pm. No decisions were made during executive session.

President Roddam read a letter dated January 18, 2023 from SLR's counsel requesting to have the preliminary hearing and the entire matter sent to SOAH. President Roddam asked for a motion to move the preliminary hearing and the full hearing to SOAH. Director Steven Wise moved to approve the request and was seconded by Director Tommy Tietjen. President Roddam then asked for any discussion from the Board.

Director Goetsch stated she didn't believe SLR's request to move the preliminary hearing to SOAH was submitted in a timely manner as the POSGCD Rules require a 14-day notice to make such request. POSGCD Attorney, Barbara Boulware-Wells noted that Chapter 36.416 subsection B states that there is a requirement of 14 days prior to date of evidentiary hearing. Ms. Boulware-Wells said she concurred that there is a timeliness issue but believes the issue could ultimately be overcome by applicant.

Molly Cagle, attorney for SLR, stated she didn't believe the request was untimely and they had not been given 14 days to make the request to move both the preliminary hearing and evidentiary hearing to SOAH. She filed objections immediately before the meeting and asserted in such objections that the original notice did not address the evidentiary hearing. Ms. Cagle said she believed that was in direct conflict with the original notice posted by POSGCD and SLR was not given 14 days to make the request of having the preliminary hearing and evidentiary hearing moved to SOAH due to the Board meeting agenda being posted less than the 14 days.

After discussion between the Board, Ms. Boulware-Wells and Ms. Cagle, President Roddam asked for a vote on the motion to approve the request to have the preliminary hearing and the evidentiary hearing sent to SOAH. After the voice vote President Roddam called for a roll call vote. The motion passed with 5 to 4, with Directors Wilder, Wise, Tietjen, Wilson, and Roddam voting in favor, and Directors Evers, Redington, Goetsch, and Worley voting against.

4. Public Comment

President Roddam opened up public comment.

Stan Mitchell made public comment regarding concerns of permitting and the Modeled Available Groundwater (MAG) in the Simsboro aquifer and the affects approval of these permits might have on aquifer conditions.

President Roddam recognized Jeff Howell's request to make public comment. Mr. Howell decided not to make any comment at this time.

Andy Wier provided a presentation regarding drawdowns that would occur in the Simsboro aquifer if the SLR permit applications were approved and stated the GAM is not able to properly predict impacts.

Kirk Rhum made public comment about the impacts to his groundwater that would occur if the SLR permit applications were approved.

Barbara Holly, City Manager for the City of Rockdale stated she would not provide comment at this time, reserving it for preliminary hearing.

Colby Coerver made public comment about the effects of regional pumping on the aquifers and wells of local landowners if the SLR permit applications were approved.

Don Schuerman made public comment regarding concerns of subsidence which might be caused by production under an approved permit and asked the Board to establish requirements on the applicant to monitor subsidence if approved.

Curtis Chubb made public comment regarding contamination of the groundwater surrounding Alcoa/SLR properties and asked the Board to require monitoring wells to ensure contamination would be contained in current locations should the Board approve the applications.

President Roddam asked if anyone else desired to provide comment. No further comments were offered.

Alan Gardenhire, with SLR, requested to make comment. President Roddam stated he would allow Mr. Gardenhire to present to the Board as long as it did not include topics that would've taken place during the Preliminary Hearing. Mr. Gardenhire overviewed a presentation, spoke about the history of Alcoa, the purchase of Alcoa property by SLR, and the economic benefits provided by SLR's ownership of the property.

With the motion to approve moving all hearings to SOAH, President Roddam moved to Agenda item 6.

SLR, whose address is 2100 Ross Ave., Ste. 895, Dallas, TX 75201, submitted an application on October 14, 2022, for a new Drilling and Operating Permit to produce up to 9,000 af/yr from the Simsboro formation, and up to 4,500 af/yr from the Hooper formation, provided that the total production in any one year may not exceed 9,000 acre-feet. SLR requests authorization to drill and operate up to a total of 60 new wells (up to 30 new Simsboro wells and up to 30 new Hooper wells), at 30 defined well sites (OP9-1 through OP9-30 for Simsboro and (OPH9-1 through OPH9-30 for Hooper.
