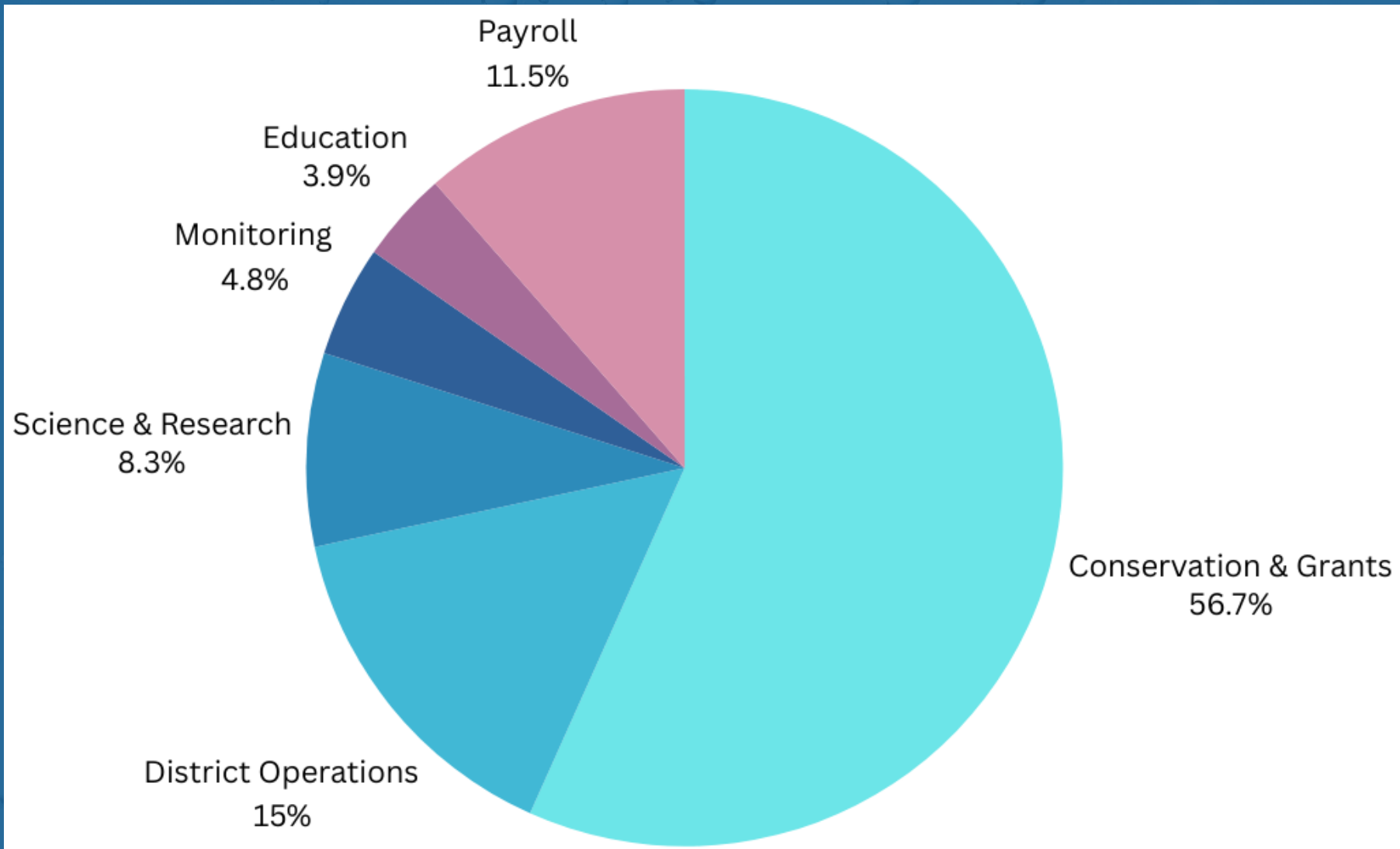

# Grant Money Back to Local Landowners

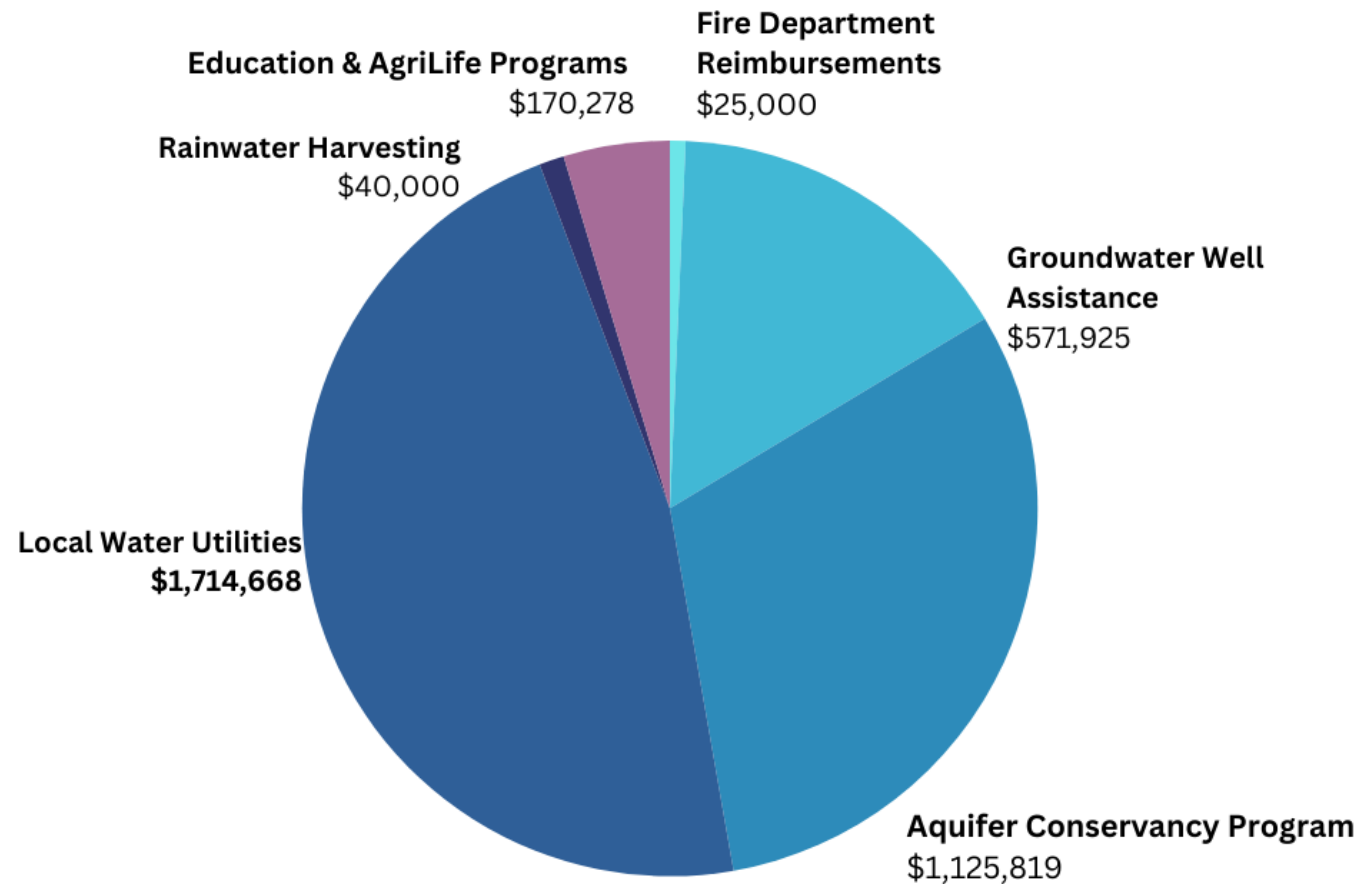
- \*\*LOCAL WATER UTILITY GRANTS, \$1.7M AWARDED 2024 (OVER \$19M SINCE 2006)
- \*\*FIRE DEPARTMENT REIMBURSEMENT GRANT UP TO \$25,000 / YEAR
- WELL PLUGGING GRANT PROGRAM – POSGCD WILL PAY UP TO \$3,500 PER WELL
- \*\*AQUIFER CONSERVANCY PROGRAM- OVER \$1.2M / YEAR TO LANDOWNERS
- AQUIFER IMPROVEMENTS PROGRAM – BRUSH CONTROL, AGRICULTURAL IRRIGATION \$361,096 PER YEAR
- \*\*WELL ASSISTANCE PROGRAM – OVER \$1.4M AND 140 WELLS SERVICED
- RAINWATER HARVESTING GRANTS-\$5,000 MAX/FAMILY, \$40,000 PER YEAR
- \*\* REPRESENTS PROGRAMS BEING EVALUATED IN 2024

# VISTA RIDGE TEMPORARY PERMIT AMENDMENT

APPROVED BY BOARD APRIL 11, 2023

- >PURPOSE: TO DECREASE PRODUCTION FROM CARRIZO AQUIFER
  - >2023 CARRIZO PRODUCTION DECREASED FROM 15,000 ACRE FT. TO 12,612
  - >TERM: EXTENDED THROUGH APR. 2024
  - >NO CHANGE TO TOTAL AMOUNT OF WATER PERMITTED
  - >VISTA RIDGE TO APPLY FOR PERMANENT AMENDMENTS TO REDUCE CARRIZO PRODUCTION
  - >REQUIRES COMPLETION OF PREVIOUSLY PERMITTED SIMSBORO WELL
  - >REQUIRES ALL DATA AND MEASUREMENTS ON PRODUCTION/WATER LEVELS
  - >MONTHLY UPDATES TO BOARD
- ONGOING REPORTS TO BOARD TO ENSURE SUCCESS
