c. Williamson County Pre-Legislative Summit of October 9, 2024

I was invited and spoke at this event two years ago and my message was that the folks who are in need of water should focus on system efficiency, including repair of obsolete and leaking pipes, as well as resilient sources of water instead of just planning to acquire additional sources from the Carrizo-Wilcox as has been the norm for the past 20 years. I will briefly discuss items of concern from our summit in July with respect to the number of projects planned to draw from that aquifer and the possible consequences in the future.

b) Presentation concerning Texas Runs on Water Campaign

Texas Runs on Water is a state-wide campaign to raise awareness on water similar to the very successful "Don't Mess with Texas" campaign and the way it was used to raise awareness concerning highway litter in this state several decades ago. Staff believes using this campaign is the best path forward to advancing not only the worthwhile concerns about water conservation but also to be able to use this platform to advance education about our ACP locally and to increase enrolments in the ACP. This will be a presentation which is focused on those discussions. Part of the draft budget for 2025 includes use of this or a similar effort to increase awareness and enrolment in the ACP. e) Adoption of Post Oak Savannah Groundwater Conservation District's Covered Applications and Prohibited Technology Policy, Dated: September 16, 2024, Version: 1.0, as required by Texas Government Code, Section 620.003.

This item is included in your packet and is required by statute which was passed into law this past session. This must be adopted by all government agencies in Texas by November 1, 2024.

f) Update on comments received during Public Comment at September 10, 2024 Board Meeting

I will give a brief report on what we have provided in the way of assistance to the gentleman who spoke at the last meeting.

g) Amend Personnel Policies

The Advisory Committee has worked with staff to amend these policies according to direction from the Board at recent meetings. The sections which were added or amended for consideration deal with Sick Leave, Holidays, Annual Leave, and Disability Leave and considerations. These draft policies are included in your packet and are properly before you for consideration, approval and amendment.

h) Amend Board Policies

As there are some common areas contained in both the Personnel and Board Policies and amending those parts of the Board Policies to remain consistent with the Personnel Policies is necessary. The only section necessary for consideration at this time is Holiday Schedule in Section 8.M. These draft policies are included in your packet and are properly before you for consideration, approval and amendment.

i) Amend 2024 Budget

In your packets is a spreadsheet with recommended amendments to the 2024 budget as well as the first look at the draft of the 2025 Budget. Amendment to the 2024 Budget is recommended to include several important changes previously approved by the Board, including the addition of line items which were not in the original 2024 Budget. Those new items are noted, and notes relating to the recommended 2024 amendments are contained in the first of two column farthest to the right. These amendments were discussed by the Advisory Committee, which serves as our committee with oversight to budget and finance and are recommended for your approval. j) First look at draft 2025 Budget

Staff put together a draft of the 2025 Budget and reviewed that item with the Advisory Committee in consideration of recent discussions and actions by the Board. The draft 2025 Budget is also included in the same spreadsheet as the 2024 Budget so you can see the flow of development and compare years. Notes related to changes are in the far right column of the spreadsheet. The Draft Budget Notes for 2025 are also included in your packets. This draft 2025 Budget is recommended by the Advisory Committee. We will discuss the draft 2025 Budget at the meeting and I will ask you for direction on posting for public hearings and adoption at our November 12, 2024 Board Meeting.
